

DECISION ON THE EXTENSION OF THE VALIDITY OF EXISTING RESERVE LISTS

The Executive Director and the Chair of the Security Accreditation Board of the European GNSS Agency (GSA),

HAVING REGARD to the Regulation (EU) No 912/2010 of the European Parliament and of the Council of 22 September 2010 setting up the European GNSS Agency, as amended by Regulation (EU) No 512/2014 of the European Parliament and of the Council of 16 April 2014,

HAVING REGARD to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials (SR) and the Conditions of Employment of Other Servants (CEOS) of the European Economic Community and the European Atomic Energy Community, and in particular Articles 12(5) and 82(6) CEOS,

Validity of existing reserve lists


Taking into consideration the interest of the service, the validity of the reserve lists included in Annex 1 shall be extended until 31 December 2021.
