



## Decision on the extension of the validity of existing reserve lists

The Executive Director and the Chair of the Security Accreditation Board of the European Union Agency for the Space Programme (EUSPA),

HAVING REGARD to the Regulation (EU) 2021/696 of the European Parliament and of the Council of 28 April 2021 establishing the Union Space Programme and the European Union Agency for the Space Programme and repealing Regulations (EU) No 912/2010, (EU) No 1285/2013 and (EU) No 377/2014 and Decision No 541/2014/EU,

HAVING REGARD to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials (SR) and the Conditions of Employment of Other Servants (CEOS) of the Europe an Economic Community and the European Atomic Energy Community, and in particular Articles 12(5) and 82(6) CEOS,

#### Article 1
