The general aim of the project is to conduct a critical review of the current Galileo integrity baseline concept, based on the evolution of integrity requirements for Galileo, and receive proposals for new global Galileo integrity concepts.

This project includes the execution of the following tasks:

- task 1: overall management of the project,
- task 2: Galileo integrity,
- task 3: Galileo search and rescue service consolidation.

III.1.1) **Deposits and guarantees required:**

For any pre-financing higher than EUR 100 000, a financial guarantee equivalent to the amount of the pre-financing will be requested. Depending on the financial situation of the tenderer, GSA may ask for the financial guarantee for amounts lower than EUR 100 000.

Payments shall be made in accordance with the provisions specified in the service contract. The maximum payment period is 30 days.

Groupings, irrespective of their legal form, may submit bids. Tenderers may, after forming a grouping, submit a joint bid on condition that it complies with the rules of competition. If awarded, the contract will be signed by the company of the person heading the project, who will be, 'vis-à-vis' GSA, the only contracting party responsible for the performance of this contract.
