The general aim of the project is to define the roadmap for the coordination and harmonisation of the European GNSS simulation and testing infrastructure.

II.2.1) **Total quantity or scope:**

The contract includes the execution of the following tasks:

- task 1: management,
- task 2: analysis of present and future user needs,
- task 3: survey of European GNSS simulation tools, laboratories and testbeds,
- task 4: European GNSS simulation and testing infrastructure definition,
- task 5: implementation roadmap for the European GSTI.

Estimated value: EUR 500 000, excluding VAT.

If awarded, the contract will be signed by the company of the person heading the project, who will be, 'vis-à-vis' GSA, the only contracting party responsible for the performance of this contract.
