2) Page 19 of the tender specifications is amended as follows:

The following Section 3.1.1 is added after Section 3.1:

“3.1.1 EU Restrictive Measures

The Tenderer shall provide a statement in the Cover Letter of their Tender (on his behalf and on behalf of his subcontractors, Core Team or not) guaranteeing that the Tenderer, and his subcontractors and respective relevant persons (the term “respective relevant persons” is meant to refer to the natural or legal persons indicated in section 4 of the Declaration of Honour [Annex I]) are not a Restricted Person and do not fall under the scope of EU Restrictive Measures in the list published at www.sanctionsmap.eu. In case of discrepancies between “www.sanctionsmap.eu” and the restrictive measures published in the Official Journal of the EU, the latter prevails.

Funds under this Procurement procedure shall not be made available, directly or indirectly, to, or for the benefit of any Restricted Person.

Please see also Declaration of Honour (Annex I) hereto (see section 4 applicable and to be provided completed and duly signed by all Tenderers and Subcontractors – Core Team or not).”
