

Corrigendum No. 1

Procurement procedure: GSA/OP/05/19 – “Development of an advanced interference detection and robustness capabilities system”

(WFID: 254463)

Annex I.K to the Invitation to tender “Template Non – Disclosure Undertaking” is modified as follows:

I. Article 1 – Definitions

For the purpose of this Undertaking:

"Proprietary Information" shall refer to the Applicable Documents listed in section 9.1 of the Security Aspects Letter (Annex I.J to the Tender Specifications).

"Classified" shall refer to European Union classified information (such as RESTREINT UE/EU RESTRICTED, CONFIDENTIEL UE/EU CONFIDENTIAL, SECRET UE/EU SECRET).

"Purpose" shall refer to the Recipient’s participation or involvement in procurement procedure GSA/OP/05/19 and to the provision of services as described in the Tender Specifications.

II. Article 4 – Duration of this Undertaking and protection of the Proprietary Information

4.1 The effective date of this Undertaking shall be the date on which it is signed. This Undertaking shall remain in force for 10 years as from its signature unless a contract is signed including confidentiality obligations according to the following paragraph.

Following signature of such a contract as a result of the tender, any information exchanged for the purpose of conclusion and execution of the contract signed following the tender is not covered by this Undertaking but by the resulting contract.

4.2 Upon the expiration of this Undertaking, the Recipient shall return to the GSA headquarters all the Proprietary Information and any copies made of them.

4.3 The Recipient shall use all reasonable endeavours to ensure that any third parties to whom the Recipient has supplied any Proprietary Information according to Article 2.3 and 2.4 above, return (in line with the previous paragraph) such Proprietary Information and any copies made of them.

4.4 Without prejudice to the provisions of the second paragraph of Article 4.1, if at any point during the validity of this Undertaking, the Recipient no longer meets the conditions for access to the Proprietary Information, namely:

(i) has no longer Local Security Officer appointed as requested in section 2.11.12 of the Tender Specifications, or

(ii) is no longer compliant with the requirement set in section 2.11.8 (a) of the Tender Specifications,

it shall return immediately to the GSA the Classified Proprietary Information - in the case under letter (i), or all the Proprietary information - in the case of letter (ii) above.

4.5 Should the Recipient return any Proprietary Information according with Article 4.4, all the other provisions of this Undertaking remain valid.
