 - A list of the legal entities involved, specifying each entity's role and qualifications and the share of the FWC total price that will be covered by the respective entity's contribution;
 - Tenderer's contact details.
 - A declaration that any of the entities involved are not a Restricted Person and do not fall under the scope of subject to EU Restrictive Measures in the list published at www.sanctionsmap.eu.
