

6. This invitation is in no way binding on EUSPA. EUSPA's contractual relationship commences only upon signature of the contract with the successful tenderer. Up to the point of signature, EUSPA may either abandon the procurement or cancel the award procedure, without candidates or tenderers being entitled to claim any compensation.
