Question #16:

In the Annex I - Tender Specifications, Par. 2.1.1, pag.13, is stated: "For implementation of the Contract to be awarded under this procurement, TO shall be understood as the date of the kick-off meeting. At this meeting the Agency will provide the contractor with all required Customer Furnished Items (CFI) documentation."

Could you please clarify which are the CFIs to be used in the "PRIMO" project and which is the expected level of integration?

Answer:

For the moment, no CFI is foreseen. The need for CFI provision by the Agency may be updated in the request for the BAFO, following the conclusion of all preceding phases (including negotiation if necessary) of the procurement.

Annex I.H SAL §5 [REQ5.1], page 7, reads: "The contractor shall mark EUCI at security classification level, as determined in the relevant SCG [AD-2] in accordance with Article 3 of Decision 2015/444 [RD-2] and Articles 8 of its implementing rules listed under RD-4, and in accordance with Article 3 of Decision of the Administrative Board on the security rules for protecting EUCI [RD-3]."

- However, RD-4 Article 8 addresses RfV (not marking of EUCI). Please provide clarification which is the correct RD Article.
- Probably RD-3 Article 3 should be read as Annex, Chapter 1, Article 3 correct? Please provide confirmation about the correct RD and article thereof.
