"In application of Article 127(7)(b) of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Union Atomic Energy Community, neither natural persons having citizenship of the United Kingdom nor legal



persons established in the United Kingdom may participate in the present tender procedure in the capacity of candidates, tenderers or subcontractors because this procedure involve access to security-related sensitive information.

Any reference to a EU Member State in the present tender specifications shall be understood as not referring to the United Kingdom.”
